

# Northamber PLC Sales Promotion Terms and Conditions

### **Promotion Overview**

Northamber PLC is excited to announce a sales promotion for its Reseller partners. By purchasing products from five participating vendors between October 1st, 2024, and April 4th, 2025, Resellers can earn points and have a chance to win an all-expenses-paid trip to Dubai for the GISEC 2025 event.

### **1. Promotion Period**

- The promotion begins on October 1st, 2024, and ends on April 4th, 2025.
- Purchases made within this timeframe are eligible to accrue points.

# 2. Eligible Participants

- The promotion is open to Resellers registered with Northamber PLC.
- All participants must be authorized and active Northamber PLC account holders.
- Participants MUST be registered to take part through the dedicated registration page.

### 3. Participating Vendors

Points can be earned by purchasing products from the following six vendors:

- 1. NETGEAR
- 2. Censornet
- 3. Branddefence
- 4. Bullwall
- 5. WatchGuard

# 4. How to Earn Points

- Resellers will earn **1,000 points** for every **£1,000 spent** on products from any single participating vendor.
- Points will be calculated based on total order value, excluding VAT and shipping fees.
- **Example**: A £5,000 order with any participating vendor will result in 5,000 points.

# 5. Bonus Points

- Mixed Vendor Orders: If a single order includes products from two or more of the participating vendors (combined to make up a total of £1,000 or more), the points earned for that order will be doubled.
- AVail Service+ Products: If any order includes an AVail Service+ product, all points earned for that order will also be doubled.



• **Example**: A £1,000 order with products from both NETGEAR and WatchGuard, or any order containing an AVail Service+ product, will earn **2,000 points**.

# 6. The Dubai Trip Prize

- The first Reseller to accumulate 200,000 points on purchases with any single vendor will win an all-expenses-paid trip to Dubai for two to attend the GISEC 2025 event.
  - Points cannot be combined across different vendors to reach 200,000. The 200,000point threshold must be achieved with a single vendor.

## 7. Prize Details

- The prize includes:
  - Round-trip airfare to Dubai for two persons.
  - Accommodation for the duration of GISEC 2025.
  - Transfers to and from the airport and GISEC venue.
  - Meal allowances and any applicable GISEC 2025 entry fees.

- The first Reseller to reach £200,000 or 200,000 points with a single vendor will be contacted by Northamber PLC and will be required to confirm their acceptance of the prize within **10 business days**.
